# The Rant Zone

## Calling Perry Mason

On January 23, 2023 United States District Judge Dale A. Drozd dismissed the Crownholm v Richard Moore, et al lawsuit, without leave to amend, effectively preventing Crownholm and his legal representatives the Institute for Justice from pursuing an amended case at the same court. Wasting no time, the I.J. filed an appeal to the 9<sup>th</sup> Circuit Court on February 1, 2023.

The Crownholm case, if you recall, centered on our board of registration issuing a fine and citation to the proprietor of mysiteplan.com, Ryan Crownholm for practicing surveying without a license. That is what he was doing every time he put together a site plan then added boundary information and dimensions to that boundary, and the board (rightfully) called him on it. So of course, he 'lawyered up' and sued. (*Elsewhere it has been discussed that I.J. is waging a national campaign against occupation licensing using the 1<sup>st</sup> and 14<sup>th</sup> Amendments as the basis of its whacked out legal theory that showing boundary lines on a plat is freedom of speech.*)

In January, Judge Drozd did such an overwhelmingly detailed deconstruction of the I.J.'s free speech case that no one in their right mind could rule differently. But this is the 9<sup>th</sup> Circuit Court of Appeals we are talking about here - the best justice that money can buy. The 9<sup>th</sup> Circuit Court has for years been a bastion of , shall we say, liberal legal rulings, producing rights out of thin air and leaning so far left that Lady Liberty has thrown out her hip. Though the court has over 50 previous free speech cases to look at for clues as to how they might swing, the 51 justices operate in randomly assembled Limited En Banc (LEBC) groups of 10 or so members for each case they hear, rather than the entire group hearing a case. This makes it tough to spot trends. How the Crownholm appeal goes will be highly dependent on the make up of this LEBC.

ACEC, WFPS, NSPS and CLSA have all joined on an Amicus brief, which under other circumstances would be meaningful, but with this court, who knows if that will make a difference? I am hoping for the best but in the meantime I am going to teach my 6 year old grandson to use Autocad because when the dust clears, he can be ready to start his own business making site plans showing boundary information, without a care in the world. Free Speech is where its at, baby!



# New California Board of Education Framework

After four years of ‘hard’ work, a new 1000-page framework for mathematics was recently released and approved by the California Board of Education. The signature tenet of this new policy is the recommendation to remove Algebra 1 from middle school and move it into high school. Among other less than desirable outcomes, this framework will make it that much harder to recruit land surveyors from the ranks of high school grads, in the future. Sadly, teaching for “Equity and Engagement” (as the new framework emphasizes), rather than excellence is par for the course in this state.

Somehow, this dunderheaded idea has not seemed to gather the outright contempt that it so richly deserves. It snuck out in July of 2023 with little fanfare and journalists, knowing a loser topic when they see one, are not saying much about it. Some of us have seen a minor headline here or a small commentary there, and we tsk, shake our heads and move on to other news. Let’s think about it more seriously, for just a moment.

In the interest of discouraging the natural spread in performance between achievers and non-achievers as Vonnegut outlined in a wry short story published clear back in 1961, the achievers are being punished in order not to offend the underachievers’ delicate sensibilities, (by order of the Handicapper General’s office). That is the ‘equity’ part. The engagement part is apparently telling teachers that it’s important to instruct their students about how they should feel about math. Apparently a quadratic equation has the potential to make people feel bad. And we can do better...

So what’s the big deal, you ask? Well, it’s this: pushing Algebra 1 from middle school to high school pushes Calculus out of high school in most cases. Gifted students will have to take Calculus via individual tutoring, or summer school or they will have to wait until community college, or junior college or for a regular college to give them the chance to catch up to where their peers in other states, not to mention other countries, already are. The good news? There’s no truth to the rumor that Chemistry and Physics are being replaced by Astrology...yet.

NSPS and the state surveying societies will have to rethink TrigStar and develop a new program, AlgebraStar or maybe they should throw in the towel and go with EquityStar.

# **Regulations We Know, (But Might Have Forgotten)**

**California Business and Professions Code**

**Division 3 – Professions and Vocations Generally**

**Chapter 15 – Land Surveyors**

**Article 5 – Surveying Practice**

**Section 8761 – Use of the Seal and Signature**

*We all know and are helpfully reminded (sometimes repeatedly) by local agencies that our submittals need to be stamped “Preliminary” or For Review Only or else they must bear our stamp and signature. This is because of California Business and Professions Code §8761. The same goes for any reports we might prepare – they are either “preliminary” or they are wet-stamped - no grey area there. But what about Math Closures? Are those not reports? Math closures should be organized, paginated, properly titled and should contain a cover sheet bearing the seal and stamp of the preparer as §8761(d) clearly delineates. And what about a topographic survey that appears as a sheet contained within a set of improvement plans? Even though it is in a set of improvement plans, wouldn’t it covered by (d) as well?*

## **BPC §8761**

- (a) Any licensed land surveyor or civil engineer authorized to practice land surveying may practice land surveying and prepare maps, plats, reports, descriptions, or other documentary evidence in connection with that practice.
- (b) All maps, plats, reports, descriptions, or other land surveying documents shall be prepared by, or under the responsible charge of, a licensed land surveyor or civil engineer authorized to practice land surveying and shall include his or her name and license number.
- (c) Interim maps, plats, reports, descriptions, or other land surveying documents shall include a notation as to the intended purpose of the map, plat, report, description, or other document, such as “preliminary” or “for examination only.”
- (d) All final maps, plats, reports, descriptions, or other land surveying documents issued by a licensed land surveyor or civil engineer authorized to practice land surveying shall bear the signature and seal or stamp of the licensee and the date of signing and sealing or stamping. If the land surveying document has multiple pages or sheets, the signature, seal or stamp, and date of signing and sealing or stamping shall appear, at a minimum, on the title sheet, cover sheet or page, or signature sheet, unless otherwise required by law.
- (e) It is unlawful for any person to sign, stamp, seal, or approve any map, plat, report, description, or other land surveying document unless the person is authorized to practice land surveying.
- (f) It is unlawful for any person to stamp or seal any map, plat, report, description, or other land surveying document with the seal or stamp after the certificate of the licensee that is named on the seal or stamp has expired or has been suspended or revoked, unless the certificate has been renewed or reissued.
